Do I need a certification to install a solar PV system?

It is a requirement for every solar PV system to have certification. Once your solar PV system is installed, the final prerequisite to completing your installation is obtaining one of these certificates which grants approval to connect to the national grid. Are they mandatory? Yes, it is mandatory to obtain a G98/G99 certificate.

How long does it take to register a solar PV system?

Many grid operators provide confirmation of registration within a business day however some take up to 30 working days to provide this confirmation. Your solar PV installer has the responsibility of filing this paper and should send this to you once received as you will need it to apply for the Smart Export Guarantee.

How long does it take to install solar panels?

However it is prudent in setting expectations that it can take up to 45 working days from when the grid operator determines an application is complete to receive approval to install. G98 and G99 certificates are a part of the process of installing solar panels and harnessing solar energy.

How long does it take to get a solar permit?

Always verify with your local building department, as requirements vary significantly by location. How long does the solar permitting process take in 2025? The standard timeline is 30-120 days total, including application preparation (1-2 weeks), permit review (2-8 weeks), installation (1-3 days), and final inspection (1-2 weeks).
